


EU transport goals for cities



And 'supporting measures' to facilitate alternatives, as part of a package of measures to facilitate (the best) adaptation




A few Zero Emission Zones already exist

- an increasing number are planned (eg 29 C40 cities)

Some of the Pathways to ZEZ

Tightening existing Low Emission Zones Phasing by vehicle types (Logistics, buses...) UVARs with ZEV advantages then requirements eg Delivery regulations, time windows Reducing time windows for non-EV **Requirements on Permits** Agreements with stakeholders Through planning system & conditions Making non-EV financially unattractive ZEZ by Design - removing parking & road space
